Minutes of 4th meeting of Teacher Education Appraisal Board (TEAB) held on 28th February, at 1000 hours in Conference Room, Shastri Bhavan, New Delhi and also on 5th March, 2014 at New Delhi for Tamil Nadu to discuss the proposals received from various States for implementation of TE scheme for the financial year 2014-15.

The 4th meeting of Teacher Education Appraisal Board (TEAB) under the Chairmanship of Secretary (SE&L) was held on 28th February, 2014, at 1000 hours in Conference Room, Shastri Bhavan, New Delhi under the Chairmanship of Secretary (SE&L), to discuss the proposals received from the States of Chhattisgarh, Mizoram, Tamil Nadu and Rajasthan for implementation of TE scheme for the financial year 2014-15. The list of participants is annexed.

2. Secretary (SE&L), welcomed the participants, and intimated that in view of the resource constraints the priority will be given to 'Teachers Salary'; and 'Committed liabilities mostly in terms of ongoing civil works'. He also requested the State Governments to tap possible financial assistance from the State funds to strengthen teacher education in their respective States. The Education Secretaries were requested to highlight the main issues being faced and also any clarification/discrepancies with reference to the appraisal of their Annual Work Plan. The Annual Work Plans were taken up State-wise.

3. Chhattisgarh

3.1. Shri Dinesh Srivastava, Education Secretary, Govt. of Chhattisgarh, raised the issue of the appraisal note not reflecting the financial approval amounting to Rs.44.00 crores for the civil works proposed/given in the last TEAB minutes, which was circulated.

3.2 Secretary (SE&L) clarified that the financial approval given in the body of the minutes is the correct financial approval and not as given in the annexure of the minutes. In view of this, Secretary (SE&L) clarified that financial approvals are given only with reference to actual availability of funds.

3.3. Regarding the request of the State Government for financial approval for the component 'Contingency', it was clarified that due to paucity of funds, as stated above,



only the committed liability of earlier years and salary and programme activities and civil works of BITEs for 2014-15 are being considered currently.

3.4. Regarding training of untrained 45,000 teachers, the State Govt. clarified that 9473 teachers have already been trained and 29864 additional teachers are undergoing training. There are only 6000 B.Ed. teachers who need to undergo additional 6 months refresher course to be recognized as having the requisite qualifications of D.Ed. and able to work.

3.5 After the presentation by Education Secretary, Govt. of Chhattisgarh, the TEAB was apprised that there was no financial liability of 2012-13 to be released in 2014-15. For 2013-14, 2nd installment of recurring expenditure amounting to Rs.498.56 lakhs (salary and programme and activities component) was sanctioned on 26th December, 2013. The utilization certificate is, however, awaited and there is no financial liability to be released in 2014-15. The total committed liability of central share of 2012-13 and 2013-14 is, therefore, nil.

3.6 For 2014-15, keeping in view limited availability of funds for implementation of TE scheme, the request of financial assistance was limited to 'committed liability of previous years' and 'salary and programme and activities' component of 2014-15. The request of financial assistance for other components would be considered in the next round of TEAB meeting, if additional funds are available.

3.7 On the above basis, out of Rs.5738.63 lakhs, proposed as per the Annual Work Plan submitted by the State Government, the Appraisal Team has appraised a sum of Rs.1344.72 lakhs. The Central share of Rs.1344.72 lakhs works out to Rs.1008.54 lakhs. Hence the total funds approved for release for 2014-15 works out to Rs.1008.54 lakhs (Central share), as per details given below:

3.10 Shri Dinesh Srivastava, Secretary (Education), Government of Chhattisgarh, was in agreement with the above Appraisal. After the financial approvals, the visit of Joint Review Mission and its recommendations were taken up.

3.11 Dr. Amarjit Singh, AS(E.E.I), MHRD, shared a matrix on the focus areas which has been prepared on the basis of the JRM recommendations, highlights of which are as under:


- Shortage of faculty is a major problem.
- There is no clear strategy both in in-service and pre-service training programmes.
- There is no active involvement of IASEs and CTEs in the working of DIETs. No coordination between SSA, RMSA and TE schemes of training.
- Very few real academics working in DIETs. Along with regular people, good academicians should also be appointed in DIETs.
- Teachers dissatisfied with the training programme.
- Clear strategy required for Pre-service and in-service training programmes and its relevance to the day to day needs of the school.
- Analysis of data needs to be done at the State level – to identify the districts and the TEIs which need support and strengthening.

3.12 Education Secretary, Govt. of Chhattisgarh was requested to take action on the above issues and submit an action taken note, which would be considered in the next TEAB meeting. Education Secretary was also requested to submit the names of the teacher educators identified for undertaking training under US AID programme.

4. **Rajasthan:**


4.1 Shri Naresh Pal Gangwar, School Education, Government of Rajasthan, made a presentation, highlights of which are under:

- Even though the annual requirement of teachers, both in government and private, is 12,000 to 13,000, the actual intake of teachers for training is only



1650. The State Government has therefore taken a decision that intake capacity of DIETs be increased in a phased manner, 50 seats every year, so that quality training of teachers can be given by the State rather than the teachers depending on the private sector. In order to achieve this, the Education Secretary stated that an action plan has been prepared for increasing the capacity of the DIET, by adding additional 2 class rooms every year and a request was made for financial assistance of non recurring expenditure for undertaking construction of 2 class rooms in every DIET for increasing the capacity of training of DIET. This was because financial assistance for non recurring expenditure on civil works has been deferred to next round of TEAB, in the Appraisal note circulated, due to paucity of funds. A request was made for financial assistance for civil works for construction of 2 class rooms in every DIET.

- DST Reading material for teacher education and children has been prepared for 1st year and material for 2nd year would be prepared next year. Financial assistance of Rs.36 lakh was sought under SCERT under the head 'Specific projects for academic activities', but was not agreed to. A request was made for sanctioning this amount.
- UNICEF was funding 'Life Line project' programme, under which text book related question and answer of 40,000 multiple questions with data base was prepared. UNICEF has now stopped funding. Financial assistance of Rs.27 lakhs for running this programme was sought under SCERT under the head 'Specific projects for academic activities', but not agreed. A request was made for sanctioning this amount.
- Regarding revision of curriculum, a Committee under the Chairmanship of Director SCERT has been formed and 2 meetings of the Committee have already been held.
- As regards filling up of vacancy of 30% in DIET, transfer policy has been established wherein eligible candidates are selected through walk-in interviews.
- Regarding establishment of BITEs, land has been identified (currently running from BRC centres) and financial assistance of Rs.316.00 lakhs for civil works of BITEs has been approved. A request was made that if no additional funds can be given for civil works of DIETs, then the State may be given permission for



diverting Rs.100 lakhs from the financial assistance being provided for civil works of BITEs to construction of additional class rooms in DIETs.

- Utilisation certificate in respect of civil works of 2012-13 would be submitted within 15-20 days.


4.2 After the presentation, following observations were made by the officers of TE Bureau:

- Member Secretary, NCTE stated that in take capacity of DIETs has to be looked into, as per the norms of NCTE.
- As per the scheme, the maximum permissible financial assistance under SCERT under the head 'Specific projects for academic activities', is only Rs.20 lakhs, which has already been agreed.
- Financial assistance for civil works of BITEs only is being provided in the first round of TEAB and there is no provision of diversion of partial funds from one head (BITEs) to another head (DIETs).
- A Joint Review Mission under the leadership of Prof. Vimala Ramachandran, NUEPA is scheduled to visit the State shortly.

4.3 The TEAB was appraised that 1st installment for civil works for 2012-13 amounting to Rs. 211.97 lakhs has been released and utilization certificate in respect of the same has not been received from the State Government. The 2nd installment for civil works amounting to Rs.211.97 lakhs would be released only on receipt of utilization certificate of earlier release and complete expenditure statement along with a statement that the State's share has been released and utilized.

4.4 For 2013-14, 2nd installment of recurring expenditure amounting to Rs.1670.55 lakhs (salary and programme and activities component) was sanctioned on 3rd February, 2014 and utilization certificate is awaited and there is no financial liability of 2013-14 to be released in 2014-15.

4.5 The total committed liability of central share of 2012-13 and 2013-14 is therefore Rs.211.97 lakhs to be released in 2014-15.



4.6 For 2014-15, keeping in view limited availability of funds for implementation of TE scheme, the request of financial assistance was limited to 'committed liability of previous years' and 'salary and programme and activities' component of 2014-15. The request of financial assistance for other item of components would be considered in the next round of TEAB meeting, if additional funds are available.

4.7 On the above basis, out of Rs.9323.22 lakhs, proposed as per the Annual Work Plan submitted by the State Government, the Appraisal Team has appraised a sum of Rs.6865.29 lakhs. The Central share of Rs.6865.29 lakhs works out to Rs.5148.95 lakhs. Hence the total funds approved for release for 2014-15, including committed liability of previous years, works out to Rs.5360.92 lakhs (Central share), as per details given below:

5. Mizoram:

5.1 Shri K. Lal Nghinglova, Commissioner and Secretary (Education), Government of Mizoram, made a presentation, highlights of which are under:

- 2 officials from the State had undergone training under the US AID programme in Arozina State University, which they found very useful.
- Proposal for establishment of 8 BITEs has not been submitted as the State had wanted to establish 3 new DIETs and financial assistance for civil works for

establishment of 3 new DIETs has been proposed, which has not been agreed to. He requested for re-consideration of the same, as the sites have been identified and PWD estimates obtained for establishment of these new DIETs prepared.

- Action taken note on the recommendations of JRM Team has been sent by post.
- Regarding provision of pay scales on par with UGC pay scales for officials having the requisite qualification, a proposal has been sent to Cabinet for approval. Once the cabinet approves, notification will be issued.
- Regarding augmentation of infrastructural facilities, as observed by JRM Team, it was clarified that provision of a well equipped computer lab in every DIET is under process.
- Web site is being created and people have been trained last month.
- For shared vision, a Core Group has been established for creating awareness.
- For clearing the backlog of 4000 untrained teachers, it was clarified that as the capacity of DIETs is limited (800 per year), training through ODL mode through IGNOU (1000 teachers) is proposed.
- State Govt. intimated that teachers recruited prior to 2010 were not having +2 qualifications and relaxation of qualification marks of 45% has been sought.
- Chief Minister of Mizoram had requested Hon'ble HRM to kindly provide financial assistance for civil works based on revised SOR.

5.2 After the presentation, following observations were made by the officers of the TE Bureau:

- Financial assistance for civil works of BITEs only is being provided in the first round of TEAB and financial assistance for civil works in respect of other institutions like DIETs, CTEs, IASEs and SCERT would be considered in the next round of TEAB, if additional funds are available.
- As per the schedule of training of untrained teachers, the State will not be in a position to complete the training of untrained teachers before the deadline of RTE Act.
- On being informed that NCTE has not given permission for undertaking training of teachers through face to face mode, Member Secretary NCTE intimated that

as per her memory, NCTE has given approval to the State Govt. for training of untrained 4000 teachers through OGL mode through UGC.

- Member Secretary, NCTE intimated that three years have already been given for relaxation for obtaining +2 qualification through OGL mode.
- As there was confusion in the number of teachers approved for training and mode of training of untrained teachers, the State Government representative was asked to have a detailed discussion with Member Secretary, NCTE and a detailed note be submitted to MHRD.
- As regards the request of the Chief Minister regarding financial assistance for civil works of DIETs, DRCs. IASE and SCERT, based on revised SOR, as this issue had already been considered in TEAB, the proposal would be processed on file, as per the existing rules.

5.3 The State has brought along with them the action taken on the JRM recommendations and the following are the highlights:

- Regarding the restructuring issue the Council of Ministers have approved and it is lying with the Department of Personnel (DPR). The State has requested for post creation and revised pay structure according to the UGC. The State has to keep in view that only those with the requisite qualification will get the UGC scale.
- As for promotion of Teacher educators, already the rules for promotion and recruitment of teacher educators are in place.
- Well-equipped labs have been established in the SCERT. Creation of Website are also due and software for digitalization has been developed.
- Rationalization for keeping good people in the DIETs as principles is going on and the order is about to be issued.
- With regard to clearing the backlog of untrained teachers in the State. In 2014-15 academic training is going to start in TEIs for both Pre-service and In-service programmes in all the 8 Institutes in the State.

5.4 After the presentation by Education Secretary, Govt. of Mizoram, the TEAB was appraised that 1st installment for civil works for 2012-13 amounting to Rs.987.58 lakhs has been released and utilization certificate in respect of the same has not been



received from the State Government. The 2nd installment for civil works amounting to Rs.1049.11 lakhs would be released only on receipt of utilization certificate of earlier release and complete expenditure statement along with a statement that the State's share has been released and utilized.

5.5 For 2013-14, 2nd installment of recurring expenditure amounting to Rs.740.84 lakhs (salary and programme and activities component) was sanctioned on 19th December, 2013, and utilization certificate is awaited and there is no financial liability of 2013-14 to be released in 2014-15.

5.6 The total committed liability of central share of 2012-13 and 2013-14 is therefore Rs.1049.11 lakhs to be released in 2014-15.

5.7 For 2014-15, keeping in view limited availability of funds for implementation of TE scheme, the request of financial assistance was limited to 'committed liability of previous years' and 'salary and programme and activities' component of 2014-15. The request of financial assistance for other item of components would be considered in the next round of TEAB meeting, if additional funds are available.

5.8 On the above basis, out of Rs.4093.26 lakhs, proposed as per the Annual Work Plan submitted by the State Government, the Appraisal Team has appraised a sum of Rs.1822.42 lakhs. The Central share of Rs.1822.42 lakhs works out to Rs.1640.18 lakhs. Hence the total funds approved for release for 2014-15, including committed liability of previous years, works out to Rs.2689.29 lakhs (Central share), as per details given below:

6. **Tamil Nadu:**

6.1. The State Government was informed that

- A Joint Review Mission under the leadership of Prof. Sadhana Saxena of Delhi University would be visiting the State from 28th April to 4th May, 2014.
- The State Govt. has not submitted proposal for IASEs and CTEs. The State Govt. was informed that from the next TEAB, consolidated proposal of all the institutes should be submitted for consideration of TEAB.
- State Govt. should ensure that the faculty of teacher educators should be provided with pay scales equivalent to their counter-part teaching in State Govt. universities, if not at par with the UGC pay scales.
- 3 Universities are not having Departments of Education and the State Govt. should take steps to immediately create Department of Education in these universities.
- Proposal for establishment of 7 new BITEs at Cuddalore, Kanchipuram, Nagapattinam, Perambalur, Nilgiris, Villupuram and Thiruvavarur districts was approved.

6.2 After the presentation Dr. S. Kannappan, Director, SCERT, Government of Tamil Nadu, stated that they are in agreement with the appraisal prepared.

6.3 The TEAB was appraised that there was no financial liability of 2012-13 to be released in 2014-15. For 2013-14, 2nd installment of recurring expenditure amounting to Rs.1127.15 lakhs for salary and programme components of DIETs and programme and activities of SCERT, under General Head, stands already approved but not released due to paucity of funds under the General Head. This would be released in 2014-15.

6.4 The total committed liability of central share of 2012-13 and 2013-14 is therefore Rs.1127.15 lakhs to be released in 2014-15.

6.5 For 2014-15, keeping in view limited availability of funds for implementation of TE scheme, the request of financial assistance was limited to 'committed liability of previous years' and 'salary and programme and activities' component of 2014-15. The request of financial assistance for other components would be considered in the next round of TEAB meeting, if additional funds are available.

6.6 On the above basis, out of Rs.116,45.89 lakhs, proposed as per the Annual Work Plan submitted by the State Government, the Appraisal Team has appraised a sum of



Rs.6434.92 lakhs. The Central share of Rs.6434.92 lakhs works out to Rs.4826.20 lakhs. Hence the total funds approved for release for 2014-15, including committed liability of previous years, works out to Rs.5953.35 lakhs (Central share).

6.7 As Education Secretary, dealing with the implementation of the Teacher Education Scheme, was not present in the TEAB meeting held on 28th February, 2014, the AWP was further discussed with Ms. D. Sabitha, Principal Secretary, State Govt. of Tamil Nadu, looking after the TE scheme, on 5th March, 2014, in the Chamber of Secretary (SE&L) and the financial proposal approved as below:


